#### Terms and condition:

1) Contractor has to submit manually "hard copy" of the tender document on the date 04.04.2025  
- upto 3 pm in the office of Executive Engineer otherwise tender will not be accepted.

2) Contractor has to submit following Documents

- Copy of Registration certificate from PWD, Government of Maharashtra
  - Copy of GST certificate
  - Copies of Last three year Income tax Certificate
  - Scan/ Xerox copy of EMD.
  - Copies of the similar kind of work executed in govt or semi govt sector during last 7 years mentioning year of work, name of the client, Place of the work and any other relevant details.
  - Copy of electrical license issued by Competent Authority or agreement with Electrical Contractor
  - Proof of ownership or proof of right to use equipments / machineries required for demolition.
  - Authorization letter if necessary
  - Contractor has to submit Affidavit on Rs 100/- bond paper that documents submitted by him are true.
- 3) It is the responsibility of the contractor to submit EPF and ESI of employee who are employed by him for this work.

4) Tender fee and EMD should be submitted in the name of Commissioner, Nanded Waghala City Municipal Corporation Nanded to Account Dept. of NWCMC and the receipt should be accompanied with tender.

5) Structure has to be dismantled up to road level

6) Debris of the dismantled building should be lifted, carried away and disposed off by the contractor with his own risk and cost.

7) The Contractor shall be required to hand over any valuable material(s) / furniture items to the Municipal Commissioner, NWCMC, Nanded other than mentioned in Table -2.


8) The Contractor is required to quote the amount willing to pay against the Material / debris from the dismantling / demolition.

9) The interested contractors are advised to visit the site before making the bid.

10) The successful bidder/contractor has to submit security deposit/caution money of Rs. 10,000 (Rs. TenThousand) in form of **Demand Draft / FDR** drawn on any Scheduled/Nationalized bank payable in Nanded in favor of **The Municipal Commissioner, NWCMC, Nanded**.

11) The Municipal Commissioner, NWCMC, Nanded reserves the right to reject any or all bids without giving any reasons thereof.

## INSTRUCTIONS TO BIDDERS

- 1.6. The site of existing Gantry is located at ITI square on Shivaji Nagar main road in Nanded.
- 1.7. The Municipal Commissioner, NWCMC, Nanded invites the Tender for the demolition of **existing Gantry situated on the above mentioned location** "As is Where is" basis & safe disposal of debris from the site.
- 1.8. Each page of the Tender Document & documents submitted must be signed by the bidder or any authorized person in token of their unconditional acceptance of terms and conditions of Tender, failing which their tender will be considered invalid. (Authorization letter must be submitted along with the tender).
- 1.9. The acceptance of the bid will rest with the Municipal Commissioner, NWCMC, Nanded who does not bind himself to accept the highest bid and reserves to himself the authority to reject any or all the tenders received, without the assignment of a reason. All bids in which any of the prescribed conditions are not fulfilled will be rejected.
- 1.10. The bidder shall have all necessary demolition / dismantling / breaking equipments and machineries i.e. needle breaker, cutter, pocklain, dumpers / tippers, form work etc. in sufficient nos. to execute the demolition activity within stipulated time period.
- 1.6 Electrical part of works should be executed through an appropriate electrical licensed individual / firm (Bidders should enclose a copy of license issued by Competent Authority).
- 2.7 The bidder is advised to visit the site before submitting the bid. The bidder is also required to take measurements and finalize the quantity duly approved by the engineer-in-charge.
- 2.8 The bid shall be kept valid for 60 days from the date of opening of bids.

### 2.9 Envelope No. 2 shall contain following document:-

- **Financial Quote (Annexure – 1) on the letter head of the bidder**

## 3 CONDITION OF DEMOLITION

- 2.19 The successful bidder shall pay the **full tendered amount** and Security deposit of Rs. 10000 (Rs. Ten Thousand) will be treated as caution money for the satisfactory completion of contract before the issue of Work Order or Notice to Proceed with the Work. No demolition shall take place before such payment is made. In case the successful bidder fails to deposit the full tender amount as required, the Municipal Commissioner, NWCMC, Nanded is entitled to take necessary decision as may be deemed fit.
- 2.20 The demolition work shall be commenced only after the deposit of full amount of tender. In case the successful bidder fails to commence the work within 7 days from the date of issue of Work Order or Notice to proceed with the work, the Security Deposit / Caution Money & full tender amount shall be forfeited without any further notice.
- 2.21 The structure shall be "demolished upto road level" as mentioned **and debris to be removed safely from the site** at the expense of the successful bidder (including the provision of the necessary tackle plant, scaffolding, etc.,) within 20 days from the date of issue of Work Order or Notice to proceed with the work in all respects to the satisfaction of the Municipal Commissioner, NWCMC, Nanded. If the successful bidder fails to execute

the said work, the Municipal Commissioner, NWCMC, Nanded may get the said work executed at the risk and expenses of the Successful Bidder by employing labor paid by the NWCMC or take appropriate decisions as may be deemed fit.

- 2.22 The successful bidder shall be responsible for taking all appropriate safety measures including form work and barricading of complete site, providing Safety belts & gloves to workers and controlling falling / spreading materials.
- 2.23 Debris shall be removed from the site under the supervision of the Engineer-in-Charge of NWCMC, Nanded.
- 2.24 The successful bidder shall submit to the Engineer-in-charge of NWCMC, Nanded the complete detailed statements of the quantity of debris removed from the site. The Engineer-in-charge shall check the Contractor's statement and certify the quantity.
- 2.25 Random check of the site will be made by the Municipal Commissioner, NWCMC, Nanded or any duly authorized representative / Official.
- 2.26 The Successful Bidder shall be responsible for all types of damages done in the demolition and indemnify NWCMC against any claims on account thereof including third party and workmen's Compensation claims.
- 2.27 The successful bidder shall acquire no interest in the land comprised in the said property except a permission to enter thereon only for the purpose of demolition and shall not be entitled to reside or allow anyone to reside or remain in the property except for the watchmen.
- 2.28 No work shall be done after 7.00 P.M. without necessary permission from the Municipal Commissioner, NWCMC, Nanded.
- 2.29 The successful bidder shall not undertake blasting for demolition and shall take appropriate precautions to curtail the noise pollution within the generally acceptable limit.
- 2.30 The successful bidder shall not employ child labor and / or female labor for the work of demolition.
- 2.31 If any dispute shall arise in connection with the work the same shall be referred to the Municipal Commissioner, NWCMC, Nanded and his decision shall be final and binding on all the concerned parties.
- 2.32 The Security Deposit/Caution Money will be refunded to the successful bidder only after the expiry of 30 days from the successful completion and handing over of clear site in all respect.
- 2.33 If the successful bidder is found to be indulged in any activity which is prejudice to the right of the Municipal Commissioner, NWCMC, Nanded or has breached any instructions / conditions specified in the document or as directions issued by the Municipal Commissioner, NWCMC, Nanded, the Municipal Commissioner, NWCMC, Nanded is entitled to take necessary action as may be deemed fit.
- 2.34 Successful bidder should have to make arrangement of sufficient curtains or to erect tins to controll spreading of dust in nearby areas.
- 2.35 Successful bidder should have to make his own way to transport debris. If there is need to break compound wall for the transportation of the debris it should be reconstructed like before with his own cost.
- 2.36 The complete demolition of building and site clearance will be 15 days from the date of work order. If the agency of work failed to complete the work in stipulated time period will be penalized as according to balance work. The decision of Municipal Commissioner will be final and binding on Agency of work.
