

**1. Scope of work**

**1.1 Preparation of detailed project report and Bid process management service.**

**A) Preparation of detailed project report (DPR)**

1. Requisite surveys including to topographical and geotechnical investigation.
2. Review of existing data/ services/ infrastructure.
3. Preparation of detail drawings.
4. Preparation of detailed cost estimate.
5. Preparation of DPR with appropriate project development structures.
6. Providing assistance in obtaining administrative approval from competent authority. In case of BOT projects approval from Government Authority.
7. Preparation of Tender Document and evaluation of bid and awarding of contract.

**1.2 Project Management Consultancy (PMC) Services.**

Scope of services at project execution stage include but not limited to:

1. Proof checking, supervision of work.
2. Measurement recording.
3. Bill certification
4. Quantity & Quality monitoring as per Tender Condition

5. Progress monitoring .
6. Ensuring timely completion of work
7. Coordinating between NWCMC and Contractor.
8. Assisting NWCMC in solving issues related to site clearance, approval.
9. Solving work related issue of contractors
10. Representing NWCMC in various meetings at all levels.
11. Ensuring compliance of tender/Contract terms & conditions.

### 3. Procedure of submission of Bid.

Bid document in prescribed manners shall be received online in two parts.

**Part-I- Technical Bid-** Receipt of Tender Fee of Rs.1000/- and EMD of Rs. 5000/- should be submitted through online payment gateway. Company Profile, Details of Past Experiences, List of Technical Staff, present works in hand, office set-up, Infrastructure, Awards if any. Copy of GST Certificate, Income Tax Returns of past three years etc. Information should be submitted on company/firm letter head. All documents should be self attested. (shop act license)

**Part- II - Financial bid** - Financial bid should consist of consultancy fees in terms of percentage of project based cost. Financial bid should be submitted on firm letter and should be uploaded with authorized signature. The total Consultancy charges including all charges should not be more than 2 % of the total project cost as per Government Resolution sankiran-2018/pr.kr.54/navi 16 date 4/6/2018

The empanelled Architects or Architectural / firms / Engineer / Project Management Consultants PMC should have to submit Rs. 10,000/- towards security deposit in the form of D.D. in favour of Municipal Commissioner, NWCMC, Nanded.

### 3. Experience

Architects or Architectural / firms / Engineer / Project Management Consultants PMC should have minimum 07 Years experience including minimum 3 similar types of works.

### 4. General Condition

- 1) Work shall be allotted to the eligible DPR consultants from empanelled list.
- 2) Consultancy charges shall be applicable as per original project cost only. Charges will remain unchanged in case of increasing in project cost.
- 3) One consultant in one financial year shall be allowed works not more than 1 corer consultancy charges.
